

City Council Proceedings
July 16, 2018

The governing body of the City of Powell met in regular session at 6:00 p.m. on July 16, 2018 in the Council Chambers of City Hall. Mayor Wetzel opened the meeting and led those in attendance in reciting the Pledge of Allegiance. Mayor Wetzel called the meeting to order and the following were present: Mayor John Wetzel, Council Members Jim Hillberry, Lesli Spencer, Tim Sapp, Floyd Young and Scott Mangold. Absent Councilman Eric Paul.

City Officials: Director of Public Works Gary Butts, City Clerk Tiffany Brando, City Attorney Sandra Kitchen, Deputy City Attorney Scott Kath, Chief of Police Roy Eckerdt and Building Official Ben Hubbard.

Approval of Agenda: Councilman Mangold moved to approve the agenda, seconded by Councilwoman Spencer, unanimous approval, MOTION CARRIED.

Approval of July 2, 2018 meeting minutes. Councilman Sapp moved to approve, seconded by Councilwoman Spencer, unanimous approval, MOTION CARRIED.

PUBLIC HEARING: Transfer of Liquor License Walters Enterprise, LLC to Y&S LLC. Attorney Kitchen opened the hearing at 6:01 pm no comments closed at 6:02. Councilman Mangold moved to approve transfer of liquor license, seconded by Councilman Young, unanimous approval, MOTION CARRIED.

PUBLIC HEARING: To consider an Ordinance Amending Section 16.16.020. Attorney Kath opened the meeting at 6:04 pm Councilman Hillberry sees the need for this change. Discussion on grandfathering and Attorney Kitchen stated this would address anything in the future. Building Official Hubbard clarified the ordinance and would like to make it consistent with other city codes and may have changes if passed before second reading. Closed 6:10 pm

Ordinance No. 6, 2018: An Ordinance Amending Chapter 16.16 Adding a New Section 16.16.020 (P) Providing for a Sight Safety Triangle on the Corner Lots. Councilman Hillberry moved to approve on first reading, seconded by Councilman Sapp, unanimous approval, MOTION CARRIED.

PUBLIC HEARING: To Consider a Resolution to Amend the 2018-2019 Budget. Attorney Kitchen opened the meeting at 6:11 pm DPW Butts explained the amendments to the budget. Closed at 6:12 pm.

Resolution No. 7, 2018: A Resolution to Amend the 2018-2019 Budget. Councilman Young move to approve, seconded by Councilman Sapp, unanimous approval, MOTION CARRIED.

Agreement to purchase TYMCO Sweeper through NJPA discussed by DPW Butts. Councilman Hillberry moved to approve and authorize signatures, seconded by Councilman Young, unanimous approval, MOTION CARRIED.

Bills and Claims: Councilman Hillberry abstained #29 and Councilman Mangold abstained #36. Councilman Young made a motion the bills be allowed and authorize the Treasurer to draw warrants for payment of the same, seconded by Councilman Mangold, unanimous approval, MOTION CARRIED.

Malt Beverage Permit Sept. 7th Homesteader Days Farm to Table @ Washington Park. Councilman Mangold moved to approve, seconded by Councilwoman Spencer, unanimous approval, MOTION CARRIED.

Resolution No. 8, 2018: Resolution of Open Container Sept. 7th Farm to Table at Washington Park. Councilman Young moved to approve, seconded by Councilman Hillberry, unanimous approval, MOTION CARRIED.

Catering Permits for WYOld West Brewing Aug. 8th SBW Open House, Sept. 7th Farm to Table Sept. 8th & 9th Hitting 4 Hometown Heroes. Councilwoman Spencer moved to approve all, seconded by Councilman Mangold, unanimous approval, MOTION CARRIED.

Request waiver of fees Sept. 8th & 9th Hitting 4 Hometown Heroes Softball Tournament. Councilman Young moved to approve, seconded by Councilman Sapp, unanimous approval, MOTION CARRIED.

Resolution No. 9, 2018: Resolution for Open Container July 23rd thru July 28th at the American Legion. Councilman Mangold moved to approve, seconded by Councilman Young, unanimous approval, MOTION CARRIED.

Request for Fireworks for the Demolition Derby at the Park County Fair July 28th. Councilman Young moved to approve, seconded by Councilman Hillberry, unanimous approval, MOTION CARRIED.

Storm Collection Discussion Buddy Rae asked for council to plan for the storm drainage issues near his property at 481 Sunlight Drive and see what can be done. Showed pictures of over filled gutters and streets from runoff accumulation from a large rainstorm. Mayor Wetzel state

they would look at what is in place and the management team will look at what can be done in the future for. Councilman Mangold asked DPW Butts steps to take and he stated he would discuss with Engineering Associates and have crews make sure grates are clear from debris build up.

Grover Park Request for a reservation for a wedding Sept. 29th. Councilman Young moved to approve, seconded by Councilwoman Spencer, unanimous approval, MOTION CARRIED.

Request to Land Helicopter in City Limits for NWC Orendorf Rooftop Unit Installation. Councilman Young moved to approve, seconded by Councilwoman Spencer, unanimous approval, MOTION CARRIED.

Committee Update: Councilman Hillberry update on Shoshone Pipeline and Councilman Young on Recycle Board and YCan Board.

Ordinance No. 5, 2018 – An Ordinance Amending Section 5.08.010 of the Powell City Code by Adding a Definition for the Word “Operational” Regarding Alcoholic Beverage Licenses. Councilman Mangold moved to approve Ordinance No. 5, 2018 on third and final reading, seconded by Councilman Hillberry, unanimous approval, MOTION CARRIED.

Request for Release of Water Rights for Whitlock II Subdivision. DPW Butts explained this is only in the area with housing. Councilman Hillberry moved to approve and authorize necessary signatures, seconded by Councilman Young, unanimous approval, MOTION CARRIED.

Bid Award Refuse Cans DPW Butts is asking to award bid to Rotational Molding in the amount of \$23,070. Councilman Young moved to approve and authorize all necessary signatures, seconded by Councilman Hillberry, unanimous approval, MOTION CARRIED.

Memorandum of Understanding with Powell Economic Partnership. Christine Bekes spoke on this agreement and the changes. Councilman Mangold moved to approve, seconded by Councilwoman Spencer, unanimous approval, MOTION CARRIED.

General Announcements: DPW Butts gave an update on Absaroka Street project, Fair week and little league tournament are both next week. Chief Eckerdt was appointed as President of Wyoming Association of Sheriffs and Chiefs of Police. Also City offices will be closed at 3:30 pm on July 24th. City Clerk Brando let Council know that budgets are final and available.

There being no further business to be considered at this meeting, Councilman Young moved to adjourn, seconded by Councilman Mangold unanimous approval, MOTION CARRIED. Mayor Wetzel adjourned the regular meeting at 6:49p.m.
