

This form must be signed and fees paid no less than 72 hours (3 days) in advance to ensure park reservations for picnic shelter/band shell areas at Homesteader, Washington or Southside Parks.

All reservation fees will be forfeited if cancellations of park reservations are not made at least one (1) week prior to scheduled park usage. Refund of fees will be allowed in case of severe inclement weather upon authorization by the Parks Superintendent.

Parks open at 6 a.m. and close at 11 p.m. Restrooms at Washington Park are only open mid-April through mid-October, please ask about availability.

The undersigned further waives and releases any and all claims, demands and causes of action which the undersigned may or could assert against the City arising out of the use, operation or maintenance from the undersigned's presence or activities conducted in or upon any City property for any purpose. The undersigned further agrees to refrain from filing any claims, demands, complaints, suits or other legal or administrative complaints against the City. The undersigned acknowledges that this Release, Indemnification and Hold Harmless Agreement has the effect of relinquishing certain legal rights that the undersigned could or may otherwise assert against the City and that the undersigned is assuming financial risks and responsibilities to the City and to the general public. Further, the undersigned agrees generally to defend, indemnify and hold harmless the City from and against any and all costs, attorney's fees, liabilities, judgments, damages and other expenses which the City may incur as a result of any of the undersigned's activities in or upon City property.
