1.0 INSTRUCTIONS TO BIDDERS

1.1 Purpose

The attached Bid Specifications are submitted to solicit bids from qualified vendors for supplying asphalt services inclusive of equipment and materials for the City of Powell Street Department.

1.2 Bid Submittal

Sealed bids (using the City of Powell Bid Forms) will be accepted at City Hall, 270 North Clark Street, Powell, Wyoming, 82435, until 10:00 AM, Tuesday May 22, 2018. The bids will be publicly opened, read and canvassed on the above time and date and award made as soon thereafter as practicable. It is the bidder's responsibility alone to ensure delivery of the sealed bids to the hands of the City of Powell prior to the bid opening time stipulated in the Invitation to Bid.

1.3 Preparation of Bid

All bids must be submitted on the required bid forms. All blank spaces must be filled in, in ink or typewritten and the bid must be fully completed and executed when submitted. No alterations in the bid or in the printed forms will be acceptable.

2.0 GENERAL CONDITIONS

2.1 Bid Security

All bids must be accompanied by bid security in the form of a certified check, cashier's check or bid bond, payable without conditions to the City of Powell, in the amount of five hundred (\$500.00) dollars. The bid security will be retained by the City of Powell as liquidated damages should the successful bidder refuse or fail to enter into contract agreement within ten (10) days from the date of "Notice of Award".

2.2 Right to Reject Bids

The City of Powell reserves the right to reject any or all bids, to waive technicalities or informalities and to accept any bid deemed to be in the best interest of the City.

2.3 Failure to Perform Penalty

Should Contractor fail to perform a requested service within two (2) days, on the third day and every day henceforth that the Contractor is in default, the City shall impose a penalty of five hundred (\$500.00) dollars per day, which will be deducted from Contractor submitted invoices, for the time the Contractor is in default.

2.0 GENERAL CONDITIONS - *continued*

2.4 Wyoming State Preference

Preference is hereby given to materials, supplies, agricultural products, equipment, machinery and provisions produced, manufactured, supplied or grown in Wyoming, quality being equal to articles offered by the competitors outside of the state (16-6-106). It will be up to the successful bidder to comply with W.S. 16-6-201 through 16-6-206 Wyoming Preference Act of 1971.

2.5 Price Protection

Prices quoted in the bid shall be firm prices and not subject to increase during the term of any contractual agreement between the City and Vendor. All prices are to be F.O.B. point of delivery, less any federal excise and state sales taxes. Vendors must stipulate the expiration date of quoted prices.

2.6 Variations to the Bid Specifications

Any variations to the bid specifications must be submitted at the time of the bid opening in writing so stating the exceptions. This includes not meeting minimum specifications, or making substitutions deemed by the vendor as being equal or superior to specifications. Vendor will be responsible for satisfying the City regarding substitutions.

3.0 SELECTION PROCESS

3.1 Evaluation

Appropriate city staff will review and evaluate all bids.

3.2 Selection

Following the evaluation process described above, the evaluation staff will present their recommendation to the City Administrator. The City will make all decisions regarding selection and awarding of contract. The decisions of the Mayor and Council will be considered final.

THIS AGREEMENT made and entered into this _____ day of June 2018, by and between the City of Powell, Wyoming, hereinafter called CITY and _____, Inc. of _____, _____ hereinafter called CONTRACTOR.

1. The CONTRACTOR shall furnish all asphalt related equipment and materials all of which shall be fully operational and shall be available for use as may be required or designated by the CITY for use at any and all scheduled times, locations and in any and all conditions.

2. CONTRACTOR shall maintain such insurance as will protect CONTRACTOR from claims under all applicable workman's compensation laws. CONTRACTOR shall maintain public liability and property damage insurance as will protect CONTRACTOR from any claims for injury or death of any person, or any property damage which may arise from operations under this Contract, whether such operations be by CONTRACTOR or by any subcontractor, laborers, equipment operators or any one directly or indirectly employed by CONTRACTOR or any subcontractors. CONTRACTOR shall maintain liability and property damage insurance in an amount not less than \$100,000.00/\$300,000.00. The City of Powell is to be listed as an additional named insured on CONTRACTOR'S insurance policy.

3. The CITY shall pay the CONTRACTOR for performance of the Contract, the sums set forth for the hourly rates for use of equipment as per the Asphalt Equipment Rental Rates, and material rates as per the Materials Bid Sheet.

4. CONTRACTOR shall comply with all applicable federal, state, county and municipal laws, rules, regulations and ordinances in the use and operation of all equipment and in the employment of all laborers and equipment operators.

5. CONTRACTOR shall not assign any part of the performance of this Contract, or of funds to be received thereunder by the CONTRACTOR from CITY, and no assignment will be recognized by CITY unless such assignment has had the approval of CITY and provided that any surety has been given due notice of such assignment in writing.

6. CONTRACTOR shall not sublet this Contract or any part thereof without the written consent of the CITY. In the event this Contract or any portion thereof is sublet by CONTRACTOR, with the written consent of the CITY, all obligations of the original CONTRACTOR under this Contract shall remain in full force and effect. All subcontractors must be approved by CITY before subcontractors may begin work.

7. CONTRACTOR shall, at his own cost, time and expense, furnish all equipment, repairs for said equipment, fuel, oils and labor and agrees to keep all equipment in first class operating condition at all times.

8. CONTRACTOR understands and agrees and does hereby assume full responsibility for the safety of any and all equipment operators, laborers, employees and assumes full responsibility for the safety of the equipment and does assume full responsibility for any damages or injuries done by or to the equipment, equipment operators, laborers, or other employees from any source or cause.

9. The CONTRACTOR shall furnish all labor and operators of the equipment which operator shall be fully skilled and competent to operate said equipment at all times when the work required by CITY is in progress. CONTRACTOR shall immediately remove any operator considered incompetent or undesirable by CITY. All operators and laborers provided by CONTRACTOR shall be residents of Wyoming excepting when laborers and/or operators who are residents of Wyoming are not available for employment within the State or not qualified to perform the work involved.

10. ***Should Contractor fail to perform a requested service within two (2) days, on the third day and every day henceforth that the Contractor is in default, the City shall impose a penalty of five hundred (\$500.00) dollars per day, which will be deducted from Contractor submitted invoices, for the time the Contractor is in default.***

11. The Instructions to Bidders, Asphalt Equipment Rental Rates with and without Operators, Estimated Quantities, the General Conditions, and the Specifications are all essential documents of this Contract and made a part hereof as if written herein.

12. CONTRACTOR agrees to indemnify and save harmless the CITY from and against all losses and all claims, demands, payments, suits, actions, recoveries and judgments of every nature and description brought or recovered against CITY, by reason of any act or omission of said CONTRACTOR, his agents or employees, in execution of the work or in the guarding of it.

13. Preference is hereby given to materials, supplies, agricultural products, equipment, machinery and provisions produced, manufactured, supplied or grown in Wyoming, quality being equal to articles offered by the competitors outside of the state (16-6-106).

14. The CITY of Powell, its officers, employees, appointees and representatives, do hereby reserve their governmental or sovereign immunity from tort liability of any kind or nature and nothing herein shall be considered a waiver of immunity as provided by law. City specifically retains all immunities and defenses available to it as a sovereign or governmental entity pursuant to state law, including Wyoming Statute 1-39-101, et seq.

15. This Contract shall inure to the benefit of and be binding upon the legal representatives and successors of the CITY and the CONTRACTOR respectfully.
